

# **Terms and conditions for participation in the “Air Jordan 4 Black Cat x La Marzocco Linea Mini” Giveaway**

## **1. ORGANIZER**

The organizer and host of the giveaway is Sole Brothers GmbH, Schanzenstraße 41, 51063 Cologne, Germany (hereinafter “Organizer” or “solebox”). solebox is the only organizer of this giveaway.

## **2. PARTICIPATION**

The “Air Jordan 4 Black Cat x La Marzocco Linea Mini” contest will take place from November 28, 2025, to December 5, 2025. Participation is free of charge and dependent on the purchase of goods.

### **A) ELIGIBILITY**

All natural persons who are at least 18 years of age (hereinafter referred to as “participants”) are eligible to participate in the competition. By carrying out the actions described in section 2b), the participant accepts the conditions of participation in this competition. Participants are responsible for ensuring that their contact details are correct. In the event of a violation of the conditions of participation, solebox reserves the right to exclude the persons concerned from the competition. solebox has the right, at its reasonable discretion, to subsequently revoke prizes in such cases. Employees of Sole Brothers GmbH and all companies affiliated with Sole Brothers GmbH in accordance with §§ 15 ff. AktG (German Stock Corporation Act) are excluded from the competition.

### **B) PARTICIPATION**

The entry deadline is December 5, 2025, at 11:59 p.m.

### 3. PRIZES

The prize is a La Marzocco Linea Mini espresso machine branded in collaboration with Jordan and solebox. The prize cannot be paid out in cash and cannot be exchanged. The prize cannot be transferred to third parties. The organizer reserves the right to replace the prize with a similar prize of equal or greater value.

### 4. DRAWING AND NOTIFICATION OF THE WINNER

The winner will be selected at random from all participants (who have not returned their entries). The winner will be contacted by email on January 5, 2026. To redeem the prize, the winner must respond to the email from solebox within 72 hours. The selected user is solely responsible for providing their data. In the event that the data is incorrect or incomplete, solebox reserves the right to select a new winner. In the event that the above conditions are not met, solebox reserves the right to decide whether the prize will be forfeited.

### 5. TERMINATION OF THE GIVEAWAY

solebox reserves the right to terminate the contest at any time without prior notice for important reasons.
